In registering for this clinic, the customer understands and agrees to the following cancellation/rescheduling policies:

I understand that Next Level Power Skating operates on a scheduled basis and should I be unable to attend a clinic, Next Level Power Skating will try to reschedule me for another time and date

When cancelling a clinic, I am required to provide MORE than 48-hours notice before the start time of the clinic and that cancellations that occur within that 48-hour window cannot be refunded, though they can be rescheduled

Any reschedules are dependent upon class availability

If I cancel within 48 hours, and am unable to attend any other clinic, either due to my availability or the class size restrictions for Next Level Power Skating, that I will be charged in full for that clinic

Should I cancel before the close of the 48-hour window, purchase of that clinic can be refunded or rescheduled
